### **BOARD NOTES FROM THE MEETING HELD ON SEPTEMBER 19, 2017**

## **BUILDING STATUS AND REPAIRS**

- ▶ 78<sup>th</sup> Street laundry room Jay and the plumber will be looking into the reasons why National Grid and NYC Department of Buildings have not yet approved the installation of the new meter. (See update below)
- We await final government approvals for the ramp project between the 35<sup>th</sup> Avenue and 77<sup>th</sup> Street buildings. All contractual issues with the contractor have been resolved.
- The Board reviewed a proposal from Skyline Restoration for work on the outside of the 78<sup>th</sup> Street building because of leakage. We are also looking to get other bids. We wish to obtain a second engineering opinion before beginning the work.
- The brass cleaning in all the buildings has been completed. Next the staff will be asked to paint the exterior railings.

## **GRAFFITI**

Someone spray painted graffiti in the lobby vestibule of the 77<sup>th</sup> Street building. Security footage of the event is being turned over to the police. The building staff removed the wallpaper. We have sufficient wallpaper on hand to replace the damage. Bids are being obtained to install the wallpaper.

#### **COMMUNICATIONS**

The communication committee is working on a new newsletter. It was noted that the newsletter's new section on Board meeting activity has had a positive response from residents.

## **BASEMENT TOUR**

On Wednesday, October 18 from 11:00 AM to 1:00 PM Milton will be giving a tour of the Berkeley basements for anyone interested in seeing what space is currently unused. Anyone interested in the tour should meet Milton in the lobby of the 78<sup>th</sup> Street building at 11:00 AM.

## **TREASURY APARTMENTS**

The Board has accepted a bid on apartment B37 in the 77<sup>th</sup> Street building. The price is \$505,000. There was no broker involved. We are having the contract prepared and hope to close by year end. We are preparing apartment A23 in 35<sup>th</sup> Avenue (1 bedroom) for rent. A notice will be posted to the Google group when the apartment is ready for viewing.

# **OTHER NEWS ITEMS**

## 78th STREET LAUNDRY ROOM UPDATE

National Grid is awaiting NYC Department of Buildings (DOB) approval to install a separate gas meter in the 78<sup>th</sup> Street laundry room. The issue we are having stems from the fact that National Grid and the NYC DOB have been changing the Inspection and Regulations on existing laundry rooms, which are now required be listed on the Certificate of Occupancy (CO) for each building. Our laundry rooms are not on our CO. Our CO needs to be updated, which is going to take some time to complete. These new inspection regulations will also have an impact on the laundry rooms in the other two buildings at some point. We are looking into having all 3 building CO's updated, however, 78<sup>th</sup> Street is the priority right now. The Board understands the great inconvenience this is to our 78<sup>th</sup> Street residents and we are continuing to work on restoring the gas dryers.

## FLIP TAX ON RESALE OF APARTMENTS

The results of the Flip Tax balloting follow. Fifty-four percent of the eligible apartments (144 out of 268) cast ballots. The remaining 124 either chose not to participate in the democratic process or opted for the passive 'NO' vote by not submitting a ballot.

The number of apartments approving the ballot measure was 97 while the number actively opposing the measure was 47. In the end, the requisite number of shares required (two-thirds of the outstanding 104,220 equaling 69,480) was never met. The number of shares voted in total (either 'YES' or 'NO') was 57,110 or 82% of the required number.

The Board and the Quorum Committee wish to thank Milton Rivera for his help in delivering the ballots and William Scharff for his organizational help.
